**SUBJECT:** NEW RESOURCE TO ASSIST LICENSE EXAMINEES

The California Department of Insurance (CDI) recently developed two [Candidate Information Bulletins](#) (bulletins) which are available on its Web site at [www.insurance.ca.gov](http://www.insurance.ca.gov) (in the search box on the main page, type CIB to retrieve the link to the bulletins). These bulletins provide detailed information to assist California resident license applicants to successfully pass their license examinations.

Specifically, the bulletins provide applicants with information regarding prelicensing educational objectives; describes CDI's examination site procedures; provides links to sample examination questions; offers test taking strategies; and finally, provides driving directions and public transportation options to CDI's examination sites in Sacramento, San Francisco, Los Angeles and San Diego.
